ADOPTION OF AGENDA

Adopted the agenda with the following changes: From Reference J, page 20 of 24 on Classified Personnel Recommendations, pulled the item for Position Creation/ Deletion and pulled Reference L, the naming of the Kaiser HS stadium (item to be brought back on the June 4 agenda).

MINUTES OF PREVIOUS MEETINGS

Approved the May 7, 2008 regular meeting minutes.

- Teachers/AVID Advisors JoAnn Shelly-King and Dave Unger introduced some of the Fontana High School Advancement via Individual Determination (AVID) students. The students shared with the Board all of the universities at which they had been accepted and where they planned to attend.
- Principal Dr. Sergio Flores and Teacher/Decathlon Coach Theresa Aguilar introduced some of the members of Fontana HS's Academic Decathlon Team. The team moved up to 9th place this year from 28th last year.
