ADOPTION OF AGENDA

Adopted the agenda with no changes.

MINUTES OF PREVIOUS MEETING

Approved the June 21, 2008 special meeting, June 25, 2008 regular meeting and the June 25, 2008 special meeting minutes.

RECOGNITIONS / STUDENT PRESENTATIONS

- Leonard Hernandez and Helen Fisher from the San Bernardino County Lewis Library and Technology Center gave a brief presentation on what's been going on at the library and how the County Library has been working with the Fontana Unified School District.
- Yolanda Mendoza, Associate Superintendent of Human Resources, announced the winners of the recent Green Bag Decorating Contest.

DISCUSSION/ACTION SESSION

Held a Public Hearing and adopted Resolution No. 08-41 Regarding Sufficiency of Standards-Aligned Textbooks and Instructional Materials and certified compliance with the Instructional Materials Realignment Program (IMFRP).

Held a Public Hearing and approved submission of a general waiver to the California Department of Education to waive the QEIA experience requirement at Fontana MS and Alder MS.

Adopted Resolution No. 08-93 authorizing entering into Contract No. CPRE-8289 State Preschool Program Continued Funding, Project No. 36-6771-00-8 in the amount of \$5,539,449 for the 2008-09 school year.

Approved textbook adoption at a cost of \$4,916 for the Auto Restoration 1 and 2 class at Fontana HS for the 2008-09 school year.

Ratified entering into Master Contracts with the following non-public nonsectarian schools/agencies (Altus Academy, Cathedral Home for Children, Child Help for Children, Cinnamon Hills, Heritage Schools, Inc., Oralingual School for the Hearing Impaired, Somerset Educational Center, and Universal Health Services, Inc. Keystone Education & Youth Services) for placement of students with exceptional needs in the amounts specified, effective 7/01/08 – 6/30/09.

Approved Amendments No. 1 to the agreements with Converse Consultants to cover additional geotechnical, materials and laboratory testing services, an increase of \$27,000 for Kaiser HS Stadium Project and an increase of \$62,000 for A.B. Miller HS Stadium Project, for a total increase of \$89,000.
